Phrase Codes - Remember those? They're returning to PrepExpress! Phrase Codes is a built-in library of standard title language that can be added to Schedule B of a policy. Just choose your phrase code and fill in the blanks with information that is specific to the subject property. Rumor has it that you can even add your own phrases to the library.

Lender Maintenance - You know how the CD is required to contain contact information for lenders, including license numbers? Well, it would be really helpful if the license information would carry over to the CD from Lender Maintenance. Good news! It will do just that in the upcoming program update. Thanks for your patience on that one.

Projected Payments on CD - This section will contain the option of a manual override function (the magical "M" button).
