

Recent PrepExpress® Enhancements

PrepExpress® was recently updated to include some great (at least we think so!) enhancements.

Closing Disclosure Statement

The most significant change is the new Closing Disclosure layout. Rather than using drop-down menus to access the various sections of each CD page, the user will see all of the sections of a particular page on the screen. A HUGE improvement!

Organizing Files

You can now designate files as Active or Inactive. Files that are marked Inactive will no longer appear on the list of files when you log in to PE. You may change the view to list all Inactive files or search by file name. This creates a much more organized active file list. Files may not be deleted (this is by design!).

Settlement Agent Contact Information

You may now add the contact information for main closing attorney of your firm in Tools --> Preferences. This will prevent the user from having to add the license and contact information for your firm into the Contacts area of the CD.

Policy Count Alert

Upon logging into PrepExpress, you will receive an alert indicating that you have exceeded 51% of your policy jacket limit. This means that you are less than half way to the total limit of the number of jackets you may have signed out. If you do not have overdue policies (older than 90 days) and you are getting close to your limit, we can increase the limit. Just contact Katie or Jayne.
