

CATIC to Implement New Audit Procedure

CATIC has revised its audit procedure to include a thorough analysis of trust accounts. Beginning in 2017, agents will begin receiving audit notifications from Angela Haddad, CATIC's Agency Audit Manager. Agents will receive a six week notice prior to the anticipated audit date, and they will have the option of an onsite audit in their office or a "desktop" review. A desktop review would allow the agent to electronically submit requested documentation via encrypted email to Ms. Haddad. The goal is for a collaborative audit, much like the current random Supreme Court audits that already take place in law firms throughout Vermont.

New Fire & Building Safety Code Effective 10/10/16

New code became effective on October 10, 2016. Of particular note is the matrix relative to the requirements for CO and Smoke Detectors required for various property types (see pages 34 and 35).

PrepExpress® Update

A PrepExpress software update was launched on October 14. The following are a few of the more notable enhancements to the program:


- **Refinance Discount:** You will no longer be required to enter a prior policy date and amount. If the transaction type is a refinance, the discount will automatically be calculated in the Premium Calculator.
- Contact Maintenance: Contacts may be added to your database from Contact
 Maintenance in the Tools menu. This is a handy new enhancement that will allow
 new contacts to be added in advance rather than while actually working in a

- Notice of Availability: The form was fixed so that it will now correctly display the premium amounts without having to pass through the Premium Calculator.
- Premium Calculator: Access to the Calculator is now available on Page 2 of the CD (top-right corner).
